4. Suitability / Competency of the retired employee to be reengaged and theRemunerations, allowances and leave admissible will be governed by RBE 96/2024.

5. Along with the application, copy of self-attested Service Certificate and Pension payment order shall be attached.

6. The re-engagement is subject to the orders issued by Railway Board from time to time.
