The above Financial up-gradation under Modifies Assured Career Progression Scheme is granted subject to the following conditions:

1. The above MACP in the higher grade Pay is granted in accordance with the hierarchy of the recommended revised pay bands and grade pay as given in section I, Part A of the first schedule of the Railway Services (Revised Pay) Rule 2008. They are eligible to draw higher pay from the date mentioned above.
2. There will not be any change in the Designation and the nature of the duties to be performed. The MACP benefit under this scheme is only on personal basis and it will not have any relevance to their seniority position. The station of the employees remains unchanged.
3. It will not confer any seniority benefits. His name will be continued to be maintain in the original seniority list and they will be considered for promotion on regular basis in the normal channel only.
4. In case where Financial Up-gradation under MACP scheme has already been granted and pay fixed accordingly, No further pay fixation will be granted at the time of regular promotion, if the promotion is in the higher Level only the difference of Level would be admissible at the time of regular promotion.
5. He will also entitled to avail Pass Advances Loan, TA and Higher type accommodation based on the pay fixed on financial up-gradation.
6. In terms of PBC No. 184/2017 any wrongful Promotion/Excess payment on grant of MACPs detected subsequently will be subject to rectification and recovery.
