The Promotion as SS L-8 are ordered above is subject to the following conditions.

- 1. The above Promotion for the post of Station Superintendent in Pay Matrix level-8 is provisional.
- 2. There are no DAR/SPE/Vig Cases pending against them on the date of promotion.
- 3. There shall be no change in the nomenclature/designation, duties and responsibilities and classification of the posts after Promotion and they will remain classified as Group'C'.
- 4. The above promotion will be counted as an offset against the financial promotion under MACP's.
- 5. In the case where financial promotion under MACP scheme had already been granted to level-8 & Level-9 and pay

fixed accordingly, no further pay fixation is permissible under this promotion.

6. They are allowed to exercise the option within a period of one month from the date of assuming higher responsibility as per the pro-forma attached for fixation of

pay in terms of the provision under Rule 1313 FR 22 (I) a (1) of R-II and PBC No. 308/2019 dated 07-01-2020. In case the employees do not exercise any option

within the stipulated period, it may be noted that their pay will be fixed as envisaged under Rule 1313 FR 22 (I) a(1) of R-II and no further option (revision) is

permissible as envisaged in Railway Board' letter No.PC VII/2016/1/6/2 dated 31.07.2017 (PBC No. 115/2017).

7. In terms of Board's letter No. 2018-E(SCT)I/25/9 Dated 03.06.2019 (PBC No.141/2019), the up gradation ordered above is purely provisional and subject to the final outcome of ongoing litigation/court cases on the subject.

The following employees are not eligible and the reasons noted against them

- 1.Anil K Nair [P.F.NO. 1607329735] SM/TVC. He is S.NO.1 kept in SS L-7 select list & to be promoted as SS L-7. Hence his vacancy in I-8 (1 UR) kept unfilled.
- 2. Ravi Khalko [P.F.NO.15212MAS310] SS/ABU. He is eligible but relieved on 26-03-2024 on IRT (charged against ST)
- 3. R LAKSHMI [P.F.No: 15208250649] SS/MS has been placed in the select list for promotion as Station Superintendent in Level-8 but has not been considered for promotion since withholding of Al w.e.f 01-07-2024, for a period of 6 Months NR.
