The above up-gradation are subject to the following terms and conditions :-

1. In terms of RBE No.26/2020 dt:25.02.2020 those who were already granted 2nd and 3rd MACP is now treated as 1st and 2nd MACP.
2. There will not be any change in the Designation. The MACP benefit under this scheme is only on personal basis and it shall not have any relevance to their seniority position.
3. In terms of PBC No.184/2017 any wrongful excess payment on grant of MACPs deducted subsequently will be subject to rectification and recovery.
4. Based on the recommendations of 7th CPC , the bench mark for grant of MACPs has been enhanced from "Good" to "Very Good" w.e.f 25.07.2016.
5. In terms of RBE NO.26/2020 dt:25.02.2020 the promotion from the post of ASM (GP Rs.2800) to SM (GP Rs.4200) need not be reckoned for the purpose of MACPs. As the amendment in the recruitment provisions for the Station Masters has been notified vide Board's letter dt:16.02.2018, the benefit of MACPs ignoring the promotion from ASM to SM shall be admissible w.e.f 16.02.2018.
6. **Employee should exercise the option for pay fixation within month from the date of this office Order.**
