The above approval is also subject to following conditions:

1. He is free from DAR/SPE/Vigilance cases at that time of relieving.
2. He will rank junior to all Health and Malaria Inspector in Level 6 of 7th CPC Pay Matrix / PB Grade Pay Rs.4200/- both permanent and temporary employees and his seniority will be assigned from the date of his joining in the unit to which he is posted on reporting to Jodhpur Division, Northwestern Railway.
3. He should not seek re-transfer to his Parent Railway at a later date. His lien will be maintained by this Railway until he is permanently absorbed in the new seniority unit to which he is posted.
4. He is not eligible for any benefits on transfer account, as the transfer is ordered at his own request.
5. He should be released with the instructions to report to DRM/P/Jodhpur Division Northwestern Railway for further posting.
6. He should vacate Railway Quarters if in occupation before his relief, within one month from the date of receipt of advice.
7. He should hand over all the Railway materials in his possession if any to his immediate supervisor concerned.
8. No dues/advance should be pending against him before relieving. While relieving the staff concerned, the following formalities may be completed in terms of the Railway Board's letter No.E(NG)I-2001/TR/16 dated 21.11.2001.
 - (i) The relieving order/memorandum sparing the employee should have the Photograph of the employee pasted on it duly attested in a manner that the signature of releasing Official and the rubber stamp below that appear partially on the paper outside photograph.
 - (ii) Also, the Signature and Left Thumb Impression (LTI) of the transferred employee on the relieving order/ memorandum

should be attested by the Officer signing the order/memorandum, both his name and designation, appearing below the signature.

The date of relief of the above employee may be advised to all concerned.
