The above promotion Orders are issued subject to the conditions that.

1.The date of joining the new post should be advised to this office (quoting above reference)

2. In terms of Para 113 IREM Vol-I, there is a probation period of 12 months in the promotional grade. At the end of

probation period, if the appointing authority considered that the work of the Railway servant during the one year probation period on promotion has not been satisfactory or the same is needed to be watched for some more time, they may revert the concerned employee to the post or grade from which the employee was promoted or extend the period of probation as the Case may be.

3. That there are no DAR/SPE/VIG/RP(UP) cases against the above named employee as on date, and they are not undergoing any penalty debaring them for promotion.
4. The controlling officer should also ensure that the employees should be relieved within 10 days from the date of receipt orders if not relieved or if the employees have given unwillingness for promotion, the same will be treated as refusal of promotion and they will be debarred for promotion. Consequently, They will not be eligible to be considered for the promotion before the expiry of one year of from the date of issue of this office order and they will lose their seniority and will be placed to all juniors who will be promoted in meanwhile.
5. In case where financial up gradation under MACP scheme already granted and pay fixed accordingly, no further pay fixation will arise at the time of regular promotion, if the promotion is in the same level or in the higher level of VII CPC.
6. Exercise of option permissible under rule 1313 (1)(a) (I) of the Indian Railway Establishment Code Volume-II 1987 (Sixth Edition 1987-2 and Reprint 2005) FR22 (1)(a) to get the pay fixed in the higher post/Grade Pay either from the date of the promotion/Up gradation or from the date of their next increment would be fixed accordance with clarification No. 02 of Railway Boards letter No. PC VI/2008/RSRP/1 Dt: 25.09.2008 9 PC-VI/22 RBE No. 132/2008.
7. The above promotion has been ordered only after ascertaining quantifiable data of representation of sc employees in the grade, as per the post based Roster points, in compliance with the direction of the Hon'ble Supreme Court in M.Nagaraj case.
8. The above promotion is provisional subject to further orders which may be passed by the Hon'ble Supreme Court as laid down in RBE No.91/2018 (PBC No.116/2018)
9. Employee should exercise the option within one month from the date of promotion.
