The services of Shri. R CHELLAPANDIAN, Ex.POINTSMAN "B"/JTJ, P.F.No. 15229811164, was terminated w.e.f 01.04.2000 vide penalty cited under reference 1 above, for unauthorized absence from duty.

On appeal, the Hon'ble Central Govt. Industrial Tribunal cum Labour Court, Chennai passed an Award on 27.09.2012 with direction to reinstate him into service forthwith with continuity of service & all attended benefits but without back wages. Accordingly, he was issued with call letter with specific terms and conditions vide this office letter No. M/P1(T)564/RRC/TFC 'D'(Comp. No. 179596) Dt. 11.01.2024.

On reinstatement, he had reported to this office on 22.01.2024 and was sent for remedial examination for required medical standard "AYE TWO & BELOW" and he had been declared fit in "AYE TWO with Glasses" vide ADMO/HU/NGO/MAS Lr No.067638(AR/08/01/2024) Dt. 09.02.2024. Further, He was sent to complete his training with the ongoing training batch which commenced on 12.02.2024 at MDDTI/PER.

On successful completion of the Initial course, he is now posted as POINTSMAN "B" at Jolarpettai(JTJ) under SS/JTJ, and the period from the date of reporting to the date of issue of this order may be treated as period waiting for posting orders.
